This Sweepstakes will be conducted exclusively online. Five (10) winners will each be awarded two (2) movie screening tickets ("Prize") to see the Movie Transformers: Age Of Extinction. Prize approximate retail value ("ARV") is \$27.00 USD. Total Sweepstakes ARV is \$270.00.

SWEEPSTAKES ELIGIBILITY:

Entrants must be legal residents of the 50 United States or the District of Columbia, 18 years of age or older, and complete the following actions below in order to enter and take part in this Sweepstakes.

HOW TO ENTER / EXECUTION:

Readers of www.theurbandaily.com must do the following:

1. Visit www.TheUrbanDaily.com ("Participating Website").
2. Upon entering the Participating Website, Visitors will be prompted to use RaffleCopter's widget in order to enter Sweepstakes, however, Visitors may elect to use the alternate means of online entry described below.
